The President's Perspective *Why*?

Several months ago I wrote about some of the major issues facing our community. One of those was the financial cliff facing the St. Joseph School District, in light of the loss of a previously approved operating levy. My thought was the School Board needed to establish a funding plan and work to engage and inform the community as a prelude to any future vote. To their credit, this is in fact what the Board and administration have begun doing, which we all should be supportive of and participate in.

The District has hired a firm to conduct a survey and facilitate public meetings to obtain feedback from residents. I attended one of these meetings and certainly came away with an understanding that the community will need to consider a proposal to address future funding. The Board, in the weeks ahead, will have to consider public input as well as their own opinions as to what is best for the District and work together to develop a plan to justify the need for additional funding.

There appears to be an interest on putting a proposal before voters in early April, which will require the School Board to make a decision in January. I would hope though that the School Board and administration takes the time to engage the community and allow time for discussion and debate on a proposed funding plan. I believe an issue of this importance deserves time and patience to develop a plan which clearly lays out the need for additional funding. Once presented, the community will need time to digest the plan and offer feedback, leading to a final proposal for voters to consider.

I know there is a certain amount of anxiousness to get something done. There is a serious financial issue facing the School District and, if not addressed, it will erode the School District's ability to deliver a quality education to students. As a community we cannot allow this to happen. That said, I simply offer that more time allowed for developing a consensus funding plan and providing for public input and understanding will benefit a future vote.

That said, we all need to be aware that there will be a lot riding on this future vote.
