#### Purpose

ETC Institute administered the seventh community survey for the Community Alliance of St. Joseph between March and April of 2023. The first survey was conducted in 2010. The survey was administered as part of an effort to assess citizen satisfaction with the quality of services provided by the City and County, and to gauge resident perception on many community issues, such as the livability of the community, health, education, and economic development in St. Joseph and Buchanan County. The information gathered from this survey is compared in this report to the previous survey results. A review of any changes will help community leaders review budget priorities and refine policy decisions.

### Methodology

A six-page survey was mailed to a random sample of households in the City of St. Joseph and surrounding Buchanan County. The survey was accompanied by a cover letter that included an internet link for residents who preferred to complete the survey online. Of the households that received a survey, 605 completed the survey. The results for the random sample of 605 households have a 95% level of confidence with a precision of at least +/- 4.0%.

The percentage of "don't know" responses has been excluded from many of the graphs shown in this report to facilitate valid comparisons of the results from St. Joseph and Buchanan County with the results from other communities in the national and *DirectionFinder*<sup>®</sup> databases. Since the number of "don't know" responses often reflects the utilization and awareness of city services, the percentage of "don't know" responses has been provided in the tabular data section of this report. When the "don't know" responses have been excluded, the text of this report will indicate that the responses have been excluded with the phrase "who had an opinion."

#### **MAJOR FINDINGS**

**Livability in the City/County.** Forty-six percent (46%) of the residents surveyed *who had an opinion* rated St. Joseph and Buchanan County as an "excellent" or "good" place to work (rating of 4 or 5 on a 5-point scale). Other livability issues for which respondents gave ratings of "excellent" or "good" include: overall quality of life (41%) and as a place to raise children (37%).

<u>City Amenities.</u> Seventy-six percent (76%) of the residents *who had an opinion* were satisfied with parkway walking and biking trails; 64% were satisfied with the maintenance of City parks, and 59% were satisfied with the quality of outdoor athletic fields. Residents thought the two City amenities that should receive the most emphasis over the next two years were the maintenance of City parks and City swimming pools.

<u>Cleanliness and Appearance of St. Joseph.</u> Thirty-four percent (34%) of the residents surveyed *who had an opinion* were satisfied with volunteer community clean-up initiatives; 18% were satisfied with the overall cleanliness of public spaces, and 10% were satisfied with overall cleanliness of private property.

**Feeling of Safety in the City.** Most residents (84%) surveyed *who had an opinion* felt safe at work; 81% felt safe in their neighborhood in general, and 76% felt safe in shopping areas in general.

### ASPECTS OF LIVING IN THE CITY/COUNTY

- Residents were asked about various issues that influenced their choice of where to live, and cost of living was the number one issue, followed by safety and security. These same two issues will have the most impact on their decision to stay in St. Joseph/Buchanan County for the next 10 years.
- Fifty-nine percent (59%) of residents *who had an opinion* were "very satisfied" or "satisfied" with the quality of housing for their household, and 49% were satisfied with the availability of affordable housing.
- Residents were asked about their level of agreement with various statements concerning arts, culture and museums in the area. Eighty percent (80%) agreed that arts, culture and museums should have an important role in the development of St. Joseph, and 79% agreed that arts and cultural programs for children should have an important role in the development of St. Joseph.

### **HEALTH AND WELLNESS**

• Respondents were given several health improvement opportunities and asked to provide their level of interest for each one. Residents *who had an opinion* were most interested in access to affordable healthcare services (91%), increased physical activity (85%), and expansion of mental health services (83%).



• Thirteen percent (13%) of residents *who had an opinion* are familiar with the Blueprint Plan for a System of Care for Homeless Services, and 33% *who had an opinion* are familiar with the work of the Opioid Task Force to reduce addiction in St. Joseph.

### **EDUCATION**

- Thirty-seven percent (37%) of residents *who had an opinion* rated the opportunities for gifted and talented education in the St. Joseph School District as "excellent" or "good," and 36% rated opportunities for early childhood education in the District as "excellent" or "good."
- Residents were asked to indicate their level of support for various investments in that would be used to improve the St. Joseph School District. More than three-fourths (79%) who had an opinion indicated they were "very supportive" or "somewhat supportive" of additional investments to address staffing needs, and 75% were "very supportive" or "somewhat supportive" of additional investments to address curriculum needs.
- Most residents (91%) who had an opinion "strongly agree" or "agree" that they value public education. Nearly half (48%) of residents who had an opinion "disagree" or "strongly disagree" that the community of St. Joseph values public education as much as residents of neighboring school districts.

#### **REVITALIZING OLDER NEIGHBORHOODS**

• Thirty-one percent (31%) of residents who provided a response are aware of the Urban Homesteading Program designed to help revitalize older neighborhoods. Eighty-four percent (84%) of the respondents surveyed are "very supportive" or "somewhat supportive" of revitalizing older neighborhoods in St. Joseph. Residents indicated the most valuable impact of revitalization would be improving overall community appearance.

### ST. JOSEPH 2040 PROJECT

• When asked if they were aware of the Imagine St. Joseph 2040 project, 26% who provided a response indicated they were aware. With regard to the importance of the goals of the project, respondents indicated that "investing in people (education)" was the most important goal.

### **OTHER FINDINGS**

- Residents were asked to rank the importance of various issues facing St. Joseph. The issues they ranked as most important were public safety, education and jobs.
- More than half (59%) of residents surveyed are "very supportive" or "somewhat supportive" of the City offering a comprehensive program for residential trash collection; 18% are "not supportive" and 23% indicated they need more information.
- Eighty-two percent (82%) of residents surveyed are "very supportive" or "somewhat supportive" of the City/County-funded *Grow Our Own* program with Missouri Western State University to put more law enforcement officers on the streets; 4% are "not supportive" and 14% indicated they need more information.
- Most respondents (80%) are "very supportive" or "somewhat supportive" of existing park maintenance in the City; 82% are supportive of Krug Park development, and 73% are supportive of increased community promotion for Missouri Western State University.
- Residents were asked to rate their satisfaction with various Community Alliance partner organizations. Three-fourths (75%) of the respondents who had an opinion were "very satisfied" or "satisfied" with the 139<sup>th</sup> Airlift Wing of the Missouri Air National Guard; 55% were satisfied with United Way of Greater St. Joseph, and 51% were satisfied with Missouri Western State University.



#### **Investment Priorities**

**Recommended Priorities for the Next Two Years.** In order to help the City identify investment priorities for the next two years, ETC Institute conducted an Importance-Satisfaction (I-S) analysis. This analysis examined the importance residents placed on each City amenity and their level of satisfaction with each. By identifying services of high importance and low satisfaction, the analysis identified which amenities will have the most impact on overall satisfaction with over the next two years. If the City wants to improve its overall satisfaction rating, the City should prioritize investments in amenities with the highest Importance-Satisfaction (I-S) ratings. Details regarding the methodology for the analysis are provided in Section 3 of this report.

**Overall Priorities for the City.** This analysis reviewed the importance of and satisfaction with City amenities. This analysis was conducted to help set the overall priorities for the City. Based on the results of this analysis, the amenities that are recommended as the top priorities for investment over the next two years in order to raise the City's overall satisfaction rating are listed below:

- City swimming pools (I-S Rating = 0.2933)
- Riverfront recreational development (I-S Rating = 0.2309)
- Special events and festivals (I-S Rating = 0.2052)

The table below shows the Importance-Satisfaction rating for all 13 categories of City amenities that were rated.




## Q1. Ratings of Livibility in the City/County

by percentage of respondents who rated the item as a 4 or 5 on a 5-point scale (excluding "don't know")






## Q3. Reasons That Will Have the Most Impact on Respondent's Decision to Stay in St. Joseph/Buchanan Co. for the Next 10 Years




# Satisfaction with City Amenities 2016, 2021, & 2023

by percentage of respondents who rated the item as a 4 or 5 on a 5-point scale (excluding "don't know")




## Q6. City Amenities That Should Receive the Most Emphasis Over the Next Two Years

by percentage of respondents who selected the item as one of their top three choices




# Q7. During the past year, have you visited downtown for any of the following reasons?


## Q8. Agreement with Various Statements Regarding Arts/Culture/Museums in the St. Joseph Area

by percentage of respondents who rated the item as a 1 to 5 on a 5-point scale (excluding "don't know")




## Agreement with Various Statements Regarding Arts/Culture/Museums in the St. Joseph Area 2016, 2021, & 2023


### **Q9. Satisfaction with Cleanliness and Appearance**

by percentage of respondents who rated the item as a 1 to 5 on a 5-point scale (excluding "don't know")




# Q10. How supportive would you be of the City offering a comprehensive program for residential trash collection?

by percentage of respondents




### Q11. Feeling of Safety in Various Situations




### Q12. Do you support the City/County-funded Grow Our Own program with Missouri Western State University to put more law enforcement officers on the streets?


### **Q13. Satisfaction with Housing Issues**

by percentage of respondents who rated the item as a 1 to 5 on a 5-point scale (excluding "don't know")




### Q14. Are you involved with your neighborhood association?

by percentage of respondents (excluding "not provided")




# Q15. Are you aware of the Urban Homesteading Program designed to help revitalize older neighborhoods?


# Q16. How supportive would you be of revitalizing older neighborhoods in St. Joseph?

by percentage of respondents




## Q17. Value of Economic Impact if St. Joseph Were to Invest in the Revitalization of Older Neighborhoods


### Q18. Level of Interest in Addressing Health Improvement Opportunities

by percentage of respondents who rated the item as a 1 to 4 on a 4-point scale (excluding "don't know")




### Q19. Are you familiar with the Blueprint Plan for a System of Care for Homeless Services designed to better manage and reach functional zero homelessness for St. Joseph?


## Q20. Are you familiar with the work of the Opioid Task Force to reduce addiction in St. Joseph?


## Q21. Agreement With the Following Statements Regarding Education




## Perceptions of the St. Joseph School District 2016, 2021, & 2023

by percentage of respondents who rated the item as a 4 or 5 on a 5-point scale (excluding "don't know")




# Q23. Level of Support for the Following Investments in the St. Joseph School District

by percentage of respondents who rated the item as a 1 to 4 on a 4-point scale (excluding "not provided")




# Q24. Agreement With the Following Statements Regarding the Value of Public Education

by percentage of respondents who rated the item as a 1 to 5 on a 5-point scale (excluding "don't know")




# Q26. Do you have children that have attended schools in the St. Joseph School District, now or in the past?


# Q27. Has anyone in your household attended Missouri Western State University, now or in the past?




# **Q28.** Satisfaction With Jobs and Economic Development

by percentage of respondents who rated the item as a 1 to 5 on a 5-point scale (excluding "don't know")




# Q29. Do you own a small business or are you self-employed?




## **Q30.** Level of Support for Development of Key Amenities

by percentage of respondents who rated the item as a 1 to 4 on a 4-point scale




## Q31. Are you aware of the Imagine St. Joseph 2040 project?




# Q32. Importance of the Goals of Imagine St. Joseph 2040

by percentage of respondents who rated the item as a 1 to 3 on a 3-point scale (excluding "not provided")






# Q34. Demographics: Approximately how many years have you lived in the City of St. Joseph/Buchanan Co.?




## **Q35.** Demographics: Current Employment Situation






# Q37. Demographics: Do you own or rent your current residence?




## Q38. Demographics: Age of Respondents




# Q39. Demographics: Highest Level of Education of Respondents






# Q42. Demographics: Race

# **Benchmarking Analysis**

### Overview

ETC Institute's *DirectionFinder®* program was originally developed in 1999 to help community leaders use statistically valid community survey data as a tool for making better decisions. Since November 1999, the survey has been administered in more than 500 cities and counties in 49 states. Most participating communities conduct the survey on an annual or biennial basis.

This report contains benchmarking data from two sources: (1) a national survey that was administered by ETC Institute during the fall of 2021 to a random sample of over 9,000 residents in the continental United States and (2) a regional survey that was administered by ETC Institute during the fall of 2021 to a random sample of residents living in the Plains Region of the United States. The Plains Region includes the states of North and South Dakota, Minnesota, Iowa, Nebraska, Wisconsin, Illinois, Kansas, Missouri and Oklahoma.

The charts on the following pages show how the results for the City of St. Joseph compare to the national average and the Plains regional average. The blue bar shows the results for St. Joseph. The red bar shows the Plains regional average from communities that administered the *DirectionFinder*<sup>®</sup> survey during the fall of 2021. The yellow bar shows the results of a national survey that was administered by ETC Institute to a random sample of more than 9,000 U.S. residents during the fall of 2021.




# Ratings of Livibility in the City/County St. Joseph vs. Plains Region vs. the U.S.

# **Importance-Satisfaction Analysis**

### Overview

Today, community leaders have limited resources which need to be targeted to activities that are of the most benefit to their citizens. Two of the most important criteria for decision making are (1) to target resources toward services of the <u>highest importance to citizens</u>; and (2) to target resources toward those services where <u>citizens are the least satisfied</u>.

The Importance-Satisfaction (I-S) rating is a unique tool that allows public officials to better understand both of these highly important decision-making criteria for each of the services they are providing. The Importance-Satisfaction (I-S) rating is based on the concept that public agencies will maximize overall customer satisfaction by emphasizing improvements in those areas where the level of satisfaction is relatively low, and the perceived importance of the service is relatively high.

The rating is calculated by summing the percentage of responses for items selected as the first, second, and third most important services for the City to emphasize over the next two years. The sum is then multiplied by 1 minus the percentage of respondents who indicated they were positively satisfied with the City's performance in the related area (the sum of the ratings of 4 and 5 on a 5-point scale excluding "don't know" responses). "Don't know" responses are excluded from the calculation to ensure the satisfaction ratings among service categories are comparable.

### I-S Rating = Importance x (1-Satisfaction)

### **Example of the Calculation**

Respondents were asked to identify the City amenities that were most important to emphasize over the next two years. More than one-third (34.5%) of the respondent households selected *"City swimming pools"* as one of the most important amenities for the City to emphasize.

With regard to satisfaction, 15% of respondents surveyed rated *"City swimming pools"* as a "4" or "5" on a 5-point scale (where "5" means "Very Satisfied") excluding "don't know" responses. The I-S rating was calculated by multiplying the sum of the most important percentages by one minus the sum of the satisfaction percentages. In this example, 34.5% was multiplied by 85% (1-0.15). This calculation yielded an I-S rating of 0.2933, which ranked first out of thirteen City amenities analyzed.

# **Importance-Satisfaction Analysis**



The maximum rating is 1.00 and would be achieved when 100% of the respondents select an item as one of their top three choices of importance and 0% indicate they are positively satisfied with the delivery of the service.

The lowest rating is 0.00 and could be achieved under either of the following two situations:

- If 100% of the respondents were positively satisfied with the delivery of the service
- If none (0%) of the respondents selected the service as one of the three most important areas.

### **Interpreting the Ratings**

Ratings that are greater than or equal to 0.20 identify areas that should receive significantly more emphasis over the next two years. Ratings from 0.10 to 0.20 identify service areas that should receive increased emphasis. Ratings less than 0.10 should continue to receive the current level of emphasis.

- <u>Definitely Increase</u> Emphasis (I-S > 0.20)
- Increase Current Emphasis (I-S = 0.10 0.20)
- <u>Maintain</u> Current Emphasis (I-S < 0.10)

The Importance-Satisfaction rating is based on the concept that public agencies will maximize overall customer satisfaction by emphasizing improvements in those areas where the level of satisfaction is relatively low, and the perceived importance of the service is relatively high. ETC Institute developed an Importance-Satisfaction Matrix to display the perceived importance of major services that were assessed on the survey against the perceived quality of service delivery.

The y-axis, vertical axis, represents **satisfaction** and the x-axis, horizontal axis, represents the relative **importance**. The I-S (Importance-Satisfaction) matrix should be interpreted as follows.


- **Continued Emphasis** (above average importance and above average satisfaction). This area shows where the City is meeting customer expectations. Items in this area have a significant impact on the customer's overall level of satisfaction. The City should **maintain** (or slightly increase) emphasis on items in this area.
- Exceeding Expectations (below average importance and above average satisfaction). This area shows where the City is performing significantly better than customers expect the City to perform. Items in this area do not significantly affect the overall level of satisfaction that residents have with City services. The City should <u>maintain</u> (or slightly decrease) emphasis on items in this area.
- **Opportunities for Improvement** (above average importance and below average satisfaction). This area shows where the City is not performing as well as residents expect the City to perform. This area has a significant impact on customer satisfaction, and it is highly recommended that the City **increase** emphasis on items in this area.
- Less Important (below average importance and below average satisfaction). This area shows where the City is not performing well relative to the City's performance in other areas; however, this area is generally considered to be less important to residents. This area does not significantly affect overall satisfaction with City services because the items are less important to residents. The agency should <u>maintain</u> current levels of emphasis on items in this area.
